DURING THE 2011-2012 FISCAL YEAR 1,183 CAMPERS PARTICIPATED IN SUMMER CAMP PROGRAMS; PROGRAMS INCLUDING BOTH DAY CAMP AND RESIDENTIAL CAMPS SERVING YOUTH FROM 1ST TO 12TH GRADES.
