SUMMER CAMP PROGRAMS BUILD RELATIONSHIPS AMONG YOUTH FROM DIVERSE BACKGROUNDS WITH AN EMPHASIS ON COMMUNITY BUILDING, ADVOCACY AND INCLUSION IN AGE APPROPRIATE WAYS. 2015 SERVED A TOTAL OF 1,304 CHILDREN, WHICH WAS 98% OF OUR CAPACITY. CAMP AWARDED A TOTAL OF 253 SCHOLARSHIPS, FOR A TOTAL OF \$177,217. FROM THE TOTAL OF CAMPER'S THAT ATTENDED THIS SUMMER, 36% OF RESIDENTIAL PROGRAM PARTICIPANTS RECEIVED A SCHOLARSHIP AND 8% OF DAY CAMP PARTICIPANTS RECEIVED A SCHOLARSHIP.
