SUMMER CAMP PROGRAMS BUILD RELATIONSHIPS AMONG YOUTH FROM DIVERSE SOCIO-ECONOMIC AND CULTURAL BACKGROUNDS WHO COME TOGETHER FOR SHARED ACTIVITIES IN HIDDEN VILLA'S UNIQUE ENVIRONMENT. DURING THE 2013-2014 FISCAL YEAR 1,332 CAMPER'S PARTICIPATED IN SUMMER CAMP PROGRAMS. PROGRAMS INCLUDING BOTH DAY CAMP AND RESIDENTIAL CAMPS SERVING AN EXPANDED AGE GROUP IN 2014 WITH YOUTH FROM AGES 4 THROUGH THOSE COMPLETING GRADE 12. WE ALSO ADDED A PROGRAM WITH A SCIENCE TWIST; THE SIERRA BACKPACKING TRIP FOR YOUTH ENTERING 11TH AND 12TH GRADE. OVER A THREE WEEK PROGRAM, CAMPER'S TRAVELED TO YOSEMITE AND HIKE THE SAN FRANCISCO WATER SHED. SUMMER CAMP SCHOLARSHIPS OF \$165K PROVIDE FOR LOW-INCOME FAMILIES TO ATTEND CAMP. APPROXIMATELY 33% OF RESIDENTIAL CAMPER'S ATTEND ON NEED-BASED SCHOLARSHIPS AND 9% OF DAY CAMPER'S.

HIDDEN VILLA'S TEACHING TECHNIQUES AND STRATEGIES ARE UNIQUE, STRIKING A BALANCE BETWEEN SCIENTIFIC INVESTIGATION AND FEELINGS OF WONDER, AWARENESS, APPRECIATION, AND FUN. DURING THE 2013-2014 FISCAL YEAR APPROXIMATELY 20,500 CHILDREN AND ADULTS ATTENDED THIS PROGRAM. SCHOLARSHIP SUPPORT ASSISTED 20.5% OF THOSE WHO PARTICIPATED IN HVEEP PROGRAMS DURING THIS YEAR.

WHILE THE IMPACT OF THE DROUGHT WAS FELT ACROSS HIDDEN VILLA, IT HAS ESPECIALLY EFFECTED THE PRODUCTION FOR THE CSA, AS A PLANNING MEASURE, WE CUT BACK THE NUMBER OF CSA SHARES FROM 130 TO 100 AND PLANTED CROPS THAT REQUIRED LESS WATER DURING THE GROWING SEASON. THE SHARES PRODUCED ACCOUNTED FOR 70% OF OUR PRODUCE; WITH 25% DONATED TO THE COMMUNITY SERVICES AGENCY OF MOUNTAIN VIEW WHICH SERVED OVER 3,000 CLIENTS. HIDDEN VILLA PRODUCE WAS AVAILABLE FOR PURCHASE AT THE LOS ALTOS FARMER'S MARKET ACCOUNTING FOR THE REMAINING 5% OF OUR TOTAL PRODUCTION.
