DURING THE 2012-2013 FISCAL YEAR 1,164 CAMPER'S PARTICIPATED IN SUMMER CAMP PROGRAMS. PROGRAMS INCLUDING BOTH DAY CAMP AND RESIDENTIAL CAMPS SERVING YOUTH FROM 1ST TO 12TH GRADES. SUMMER CAMP SCHOLARSHIPS OF \$161,000 PROVIDE FOR LOW-INCOME FAMILIES TO ATTEND CAMP. APPROXIMATELY 37% OF RESIDENTIAL CAMPER'S ATTEND ON NEED-BASED SCHOLARSHIPS AND 9% OF DAY CAMPER'S.
